3. PRINCIPLES OF THE QUALITY, ENVIRONMENT, SAFETY AND HEALTH POLICY

ALEATICA creates sustainable and resilient value for clients, investors and our human team, through the concession of transport infrastructures and the development of infrastructure solutions and Smart transport systems in countries with great growth potential.

In the framework of quality assurance, and the protection, conservation and improvement of safety and health and the environment, all employees must know, understand, comply and seek the dissemination of the following guidelines in the field of their professional performance:

- **Comply with** legal, regulatory, contractual and other applicable requirements.
- Persevere in development of **customer-oriented solutions** and in the design of products and services that are effective, safe and healthy, innovative, and profitable.
- Ensure **safe and healthy working conditions**, to prevent damage and deterioration of the physical, mental and social health of workers, as well as to eliminate hazards and reduce risks to OHS and encourage participation and consultation of workers and/or their representatives.
- Optimize the **consumption of** material and energy **resources** through efficiency plans, promote the use of clean and efficient **energy**, as well as **products and services** that contribute to the progress of the circular economy considering the entire life cycle.

- Manage waste, discharges and emissions to the atmosphere to **prevent pollution** with mitigation and adaptation measures; and, in particular, prevent greenhouse gases, as the main origin of **Climate Change**.
- Reduce the impact on **biodiversity** and **ecosystems**, through conservation practices and ecological restoration.
- Develop the **competences** of employees in these matters, guaranteeing their involvement and commitment. Require compliance of **suppliers** with all provisions and clauses, as well as collaborate in their awareness, training and improvement, to achieve joint growth.
